We wish to highlight that we follow our Code of Business Conduct & Ethics and we request any company willing to be part of JinkoSolar's supply chain to enter into JinkoSolar's Partner's Code of Conduct. Such Codes foresee, amongst others, our right of continued audit on our business partners and our right of termination *ad nutum* in the event of breach of the terms of the Codes by any of our business partners.
